

1. Introduction

This report is for the month of February 2018 and is published as an update to the business rescue status report for the month of January 2018 published to affected persons and filed with the Companies and Intellectual Property Commission.

2. Implementation of the Amended Business Rescue Plan and Sale Agreements

- 2.1 The Mining Right has now been registered with the Mineral and Petroleum Titles Registration Office ("**MPTRO**"). The Notarial Deed of Cession will be lodged with the MPYRO shortly.
- 2.2 The section 11 application relating to Sky Chrome (Sale of Equity and Claims Agreement) has been finalised and lodged with the Department of Mineral Resources.
- 2.3 The fulfilment of the remaining suspensive conditions relating to the Lesedi and Sky Chrome transactions continue to be monitored and progressed.

3. Creditor Distributions
