

**1. Introduction**

This report is for the month of November 2017 and is published as an update to the business rescue status report for the month of October 2017 published to affected persons and filed with the Companies and Intellectual Property Commission.

**2. Implementation of the Amended Business Rescue Plan and Sale Agreements**

- 2.1 The amendments to the power of attorney, which were required by the Mineral and Petroleum Titles Registration Office ("**MPTRO**") in respect of the approval of the Mining Right, appear to have been approved by the Department of Mineral Resources' ("**DMR**") Licencing Committee, at a meeting held on Monday, 16 October 2017.
- 2.2 The original, signed amended power of attorney and the Mining Right have been re-lodged with the MPTRO.
- 2.3 The section 11 application relating to Sky Chrome (Sale of Equity and Claims Agreement) is in the process of being finalised and lodged with the DMR. The discussions with the remaining shareholder in Sky Chrome are ongoing.
- 2.4 The fulfilment of the remaining suspensive conditions relating to the Lesedi and Sky Chrome transactions continue to be monitored and progressed.

**3. Creditor Distributions**

- 3.1 All creditors who have not yet furnished the business rescue practitioner with correct banking details must please do so immediately, so that the dividend due can be paid. Separate notices have been circulated to respective creditors.
