

**Business Rescue Status Report in terms of Section 132 (3) of the Companies Act 71
of 2008 (the "Act")**

1. Introduction

This report is for the month of May 2017 and is published as an update to the business rescue status report published to affected persons and filed with the Companies and Intellectual Property Commission on 28 April 2017.

2. Implementation of the Amended Business Rescue Plan and Sale Agreements

- 2.1 The application to the Department of Mineral Resources ("DMR") for the Section 11 transfer of the mining right of Lesedi (Sale of Mining Right Agreement) continues to be processed by the DMR.
- 2.2 Regular discussions/follow ups have been held with the DMR in relation to the above and we await the outcome of the DMR consideration.
- 2.3 The Section 11 application preparation relating to Sky Chrome (Sale of Equity and Claims Agreement) remains in process. The discussions with the remaining shareholder in Sky Chrome are ongoing.
- 2.4 The fulfilment of the remaining suspensive conditions relating to the Lesedi and Sky Chrome transactions continue to be monitored and progressed.
