**Business Rescue Status Report in terms of Section 132 (3) of the Companies Act 71 of 2008 (the "Act")**

**1. Introduction**

This report is for the month of September 2017 and is published as an update to the business rescue status report published to affected persons and filed with the Companies and Intellectual Property Commission on 31 August 2017.

**2. Implementation of the Amended Business Rescue Plan and Sale Agreements**

- 2.1 The application to the Department of Mineral Resources ("**DMR**") for the Section 11 approval to transfer the mining right of Lesedi (Sale of Mining Right Agreement) has been granted by the DMR.
- 2.2 The Mining Right was re-lodged for registration at the Mineral and Petroleum Titles Registration Office ("**the MPTRO**") on 31 July 2017. However, the MPTRO unfortunately rejected the mining right. The MPTRO raised various queries, including the requirement of an amended power of attorney being obtained from the DMR.
- 2.3 The amendments required by the MPTRO have been given effect to and the amended power of attorney is now at the DMR head office in Pretoria. Once the amended power of attorney is obtained, the relevant documents will be re-lodged with the MPTRO.
- 2.4 The section 11 application relating to Sky Chrome (Sale of Equity and Claims Agreement) is in the process of being finalised and lodged with the DMR. The discussions with the remaining shareholder in Sky Chrome are ongoing.
- 2.5 The fulfilment of the remaining suspensive conditions relating to the Lesedi and Sky Chrome transactions continue to be monitored and progressed.

### 3. **Creditor Distributions**

- 3.1 All creditors who have not yet furnished the business rescue practitioner with correct banking details into which their dividend may be paid, must please do so immediately. Separate notices have been circulated to respective creditors.
