

Business Rescue Status Report in terms of Section 132 (3) of the Companies Act 71 of 2008 (the "Act")

1. Introduction

This report is for the month of January 2018 and is published as an update to the business rescue status report for the month of December 2017 published to affected persons and filed with the Companies and Intellectual Property Commission.

2. Implementation of the Amended Business Rescue Plan and Sale Agreements

- 2.1 The original, signed amended power of attorney and the Mining Right were re-lodged with the Mineral and Petroleum Titles Registration Office ("**MPTRO**") during November 2017.
- 2.2 The MPTRO has responded with certain queries, which are being addressed.
- 2.3 The section 11 application relating to Sky Chrome (Sale of Equity and Claims Agreement) has been finalised and will be lodged once the discussions with the remaining shareholder in Sky Chrome have been finalised.
- 2.4 The fulfilment of the remaining suspensive conditions relating to the Lesedi and Sky Chrome transactions continue to be monitored and progressed.

3. Creditor Distributions

- 3.1 All creditors who have not yet furnished the business rescue practitioner with correct banking details must please do so immediately, so that the dividend due can be paid. Separate notices have been circulated to respective creditors.
