
The above named company commenced business rescue proceedings on 26 August 2015.

Business Rescue Status Report in terms of Section 132 (3) of the Companies Act 71 of 2008 (the "Act")

1. Introduction

This report is for the month of May 2019 and is published as an update to the business rescue status report for the month of April 2019 published to affected persons and filed with the Companies and Intellectual Property Commission.

2. Implementation of the Amended Business Rescue Plan and Sale Agreements

2.1 All Conditions Precedent to the Sale of Mining Right Agreement have been fulfilled. The Notarial Deed of Cession of Mining Right by IFMSA to Samancor has been registered in the Mining Titles Office.

2.2 The BRP has reached an agreement with Samancor regarding the impact on the sale agreement arising from the damage to the mine assets as a result of illegal intruders and the dispute with the insurers. The relevant addendum to the sale agreement requires the consent of the Bank of China. These discussions are ongoing and will hopefully soon reach finality.

2.3 The BRP and advisors continue to endeavour to progress the conditions precedent to the Sky Chrome transaction. The Section 11 approval was received on 30 January 2019. Ongoing discussions are continuing with representatives of the Bapo Ba Mogale Traditional Authority and a letter has been sent to the Chairperson of the Council in an endeavour to achieve fulfilment of the condition precedent.

3. Insurance Claim

3.1 The exercise being undertaken by Lloyd Warwick International South Africa (Pty) Ltd, to determine the extent of the damages/loss has been finalised and the results accepted by Samancor.

3.2 The BRP and his advisors continue to challenge the insurers' avoidance of the relevant insurance policy
